2 - FTCA malpractice coverage regarding Medicaid for our hybrid and charitable clinics...

Per the latest FTCA free clinic program guide, clinics that accept Medicaid or other reimbursement are *not* eligible for FTCA coverage: See p. 9 under eligibility: "The free clinic does not accept reimbursement from any third-party payor (including but not limited to reimbursement from an insurance policy, health plan, or other Federal or State health benefits program)."

5 - The ALICE Report <u>umich.org/alice-report</u>

If you haven't seen the report, I strongly recommend it. This report researches the cost of living across counties in Michigan and then puts their findings in this report. This is a much better reflection of the cost of living and therefore the poverty level than the amount the Federal government FPL uses.

I will tell you that once you look up your county and see the number of items that really make up the cost of living in your county you will be astounded. The report is useful for grants and presentations and if your clinic is income-based this may change that number. Take a look.

7 - Medication Donations

A clinic recently asked Christine Rainey for an opinion on OTC donations. I thought it would be of interest. If you have any questions, email Christine crainey@ferncare.org: "Are we allowed to store and give OTC donations away? Absolutely yes! One purpose of the Drug Chain Security Act (DCSA) is to ensure that dispensed prescriptions have been bought from authorized sources in order to eliminate counterfeit meds or meds that have been exposed to improper conditions. I doubt there is enough profit in counterfeiting OTCs and Rx meds are so much more profitable to counterfeit or divert – which is probably why the DCSA applies only to RX items or those dispensed as an Rx (ie: Benadryl 25mg is OTC,50mg is Rx)."

8 - Legislation

HB 5966 – Carrie Rheingans, (D) Ann Arbor – Universal publicly funded health care for all Michigan residents There has been no hearing on this so far this session. This was brought up last session but there was no action taken so Ms. Rheingans introduced it again.
