1 – 2024 FCOM Membership Dues

Stacey Doyle (stacey@gcfhc.org has sent out the renewal membership application. Last year 43 clinics joined, which was over 50% of all the clinics we knew were operating in the state. I would love to beat that number this year! **IF you did not get the renewal packet**, email Stacey, she will send it out to you.

NOTE: There are dues increase based on your annual budget this year: **§75** - clinics with budgets less than \$75,000; **§150** - budgets between \$75,000 and \$150,000; **§200** – budgets over \$150,000

2 – Yearly NAFC clinic data and Quality Standards Survey

6 – Clinic Valuation Survey

One of the last pieces of documentation that we need to incorporate into FCOM is a yearly survey of the reimbursement value of our clinics' services. This is the document that will demonstrate the financial impact and value to our communities.

Mary Lewis, CEO, Dr. Gary Burnstein Community Health Clinic and FCOM Board member and I think we have a document that will suit our purposes AND is not onerous to complete. We are talking to the state organization that designed the document and doing our own research. This is the initial announcement...... stay tuned.

7 – Legislative Update

We are making a concerted effort to increase our state appropriation. I have been told by two representatives that the state will have a decrease in funding but that does not mean that we cannot ask for an increase. Our last increase was in 2019 when we went from 250,000 to 400,000.

I will be sending out the FCOM legislative packet soon to all the clinics asking each of you to call your state rep or senator and introduce yourself and your clinic and to email the packet to each.

Each email will indicate if your rep or senator is on either one of the three Appropriations or Health Committees in the House or Senate. The real survey will be out in January. We had a great return last year; 36% more clinics completed the survey.

8 – March 5th and 6th Washington DC Advocacy Meetings

NAFC is organizing an Advocacy Day for State Association Managers. Dan Martin, Board Member and Chair of the Legislative Committee will be attending and meeting with Michigan's senators and representatives. The two-day cost is being underwritten by NAFC. The second day will be an all-day state manager meeting de-briefing and legislative strategy meeting. This is the first time NAFC has organized an event of this kind. Usually Nicole and her legislative/advocacy specialist, both based near Washington, do this work.

HB 5966 – Carrie Rheingans, (D) Ann Arbor – Universal publicly funded health care for all Michigan residents. No updates.

Broadband expansion – We continue to support all the work to extend broadband capability across the state. The work is on-going, and we will support this until capability is available to every inch of Michigan.

House Bill 5166 – Stephanie Young (D) Detroit and others - Creating a perinatal quality collaborative. We support the bill and strongly support having our ob/gyn dedicated and other clinics offering obstetric care represented on the collaborative. No updates.

9 - Medicaid Unwinding Continues.... until next May unless they extend the program
