- House Bill 6112 Legislature to form a committee
  to review going from a federally based health
  insurance exchange to a state based insurance
  exchange\* The Senate Health Policy Committee
  heard testimony (2/1/23) from DIFS (Department of
  Insurance and Financial Services) regarding start-up
  costs, user fees and the number of states that have
  left the Federal exchange to create their own
  exchange. There was no discussion of vendors of
  healthcare plans or any potential loss of benefits to
  participants. No action.
- Public Health Code 378-1976 Use of Donated
   Medications The first public hearing was held May
   2nd. Christine sent a letter outlining both our
- concerns and language that would address the concerns for their consideration.
