3 – FCOM – Outreach to Your Own & Surrounding Communities

This was created in 2021 and it is still relevant. I am attaching it to the Update as a refresher because of so many clinics reporting a drop in patient appointments and as a source for possible grant opportunities. There are a lot of ideas...I hope something sparks something that works for you.

4 – Legislative Update

HB 5966 – Carrie Rheingans, (D) Ann Arbor – Universal publicly funded health care for all Michigan residents. No meetings on the bill were scheduled.

Broadband expansion – We continue to support the work to extend broadband capability across the state. No meetings but there were two announcements detailing additional grants received to extend the capability.

House Bill 5166 – *Stephanie Young (D) Detroit and others* - Creating a perinatal quality collaborative. No meetings on the issue were scheduled.

I am meeting with Representative Regina Weiss (d) this Friday Dec. 1st). In 2017 she sponsored our appropriation increase from 250,000 to 400,000. I am hoping she will sponsor or co-sponsor an increase for the 2025 budget.
